The Transamerica LifeGoal 2025 with BlackRock Ret Acct PX is a Separate Account Sub-Account maintained by TFLIC and invests exclusively in the Transamerica LifeGoal 2025 with BlackRock Ret Opt, a Transamerica Life Insurance Company (TLIC) Separate Account. The TLIC Separate Account invests exclusively in the Transamerica LifeGoal(SM) 2025 Fund, a collective investment trust fund. Prior to 11/20/2020 this Separate Account was named the BlackRock Lifepath Index 2025 Ret Acct PX.

Investment Objective & Strategy

Objective:

The Fund seeks to maximize returns while maintaining a level of risk appropriate for a person planning to retire in or about the calendar year designated in the Fund's name.

Strategy:

The Fund will principally invest in a mix of mutual funds managed by BlackRock Institutional Trust Company, N.A. and/or an affiliate and a group annuity contract issued by and supported by the general account of Transamerica Life Insurance Company (TLIC), and may also invest in other mutual funds, exchange-traded funds, group annuity contracts and/or collective investment trusts.


